### EQUITY LINE OF CREDIT FREEZE/CLOSE FORM Please complete <u>only</u> if you have an Equity Line of credit on your property

An equity line of credit is a mortgage which a borrower can draw up to a maximum amount, as opposed to a loan for a fixed dollar amount. Fore example, with a standard mortgage you might borrower \$150,000.00, which would be paid out in it's entirely at closing. With an Equity Line of Credit you receive the lender's promise to advance up to \$150,000.00, in an amount and at a time of your choosing. You can draw on the line by writing a check, using a special credit card or in other ways. If these characteristics are not in keeping with your loan, you may have a home equity loan. Home equity loans have a similar name but are not equity lines of credit.

- It is necessary to freeze and close any credit line(s) before the equity process (aka: your financial interest) can be completed.
- Please note that once this form is sent to your lender, it will prohibit you from obtaining any further advances against your account.
- This form will authorize your lender to cancel any Equity Line of Credit associated with your home and to release information to United Title & Escrow Services, LLC.
